### Asset Register & Review of Insurance

### **Beacon Event Risk Assessment**

The Beacon will be set up and lit by the Engineer Fred Goddard who built the Beacon and the instructions in the Risk Assessment will be used to position the structure.

Ahead of the event traffic cones will need to be positioned in the layby to prevent cars parking there when the Beacon is lit.

A small number of chairs will need to be provided for those unable to stand for prolonged periods. Winterton Hall to be asked if Chairs can be borrowed for this short period.

2 Marshalls will be required to wear fluorescent vests to ensure the safe crossing of the Loxwood Road to the Beacon Event from Winterton Hall and to help with torches those walking towards the Beacon if required. Named emergency contact provided. (The Clerk).

# 8. Play Parks

## 1. Kelsey Hall Playpark:

<u>A tree survey</u> took place on 26<sup>th</sup> February to inspect the trees on the playground site for safety. The results of that survey show dead wood removal is required.

Tree Survey: The survey is attached and quotes for the works shown as necessary within the next 6 months are

SUSSEX & SURREY TREE SURGERY: £450 net FOREMANS TREES SPECIALIST LTD: TBC

The outcome of the funding application is expected end of March/April and following that the attached quote and design for the playground equipment can be ordered if acceptable to the Parish Council. The fencing quote is to match with that existing.

#### 9. Clerk's update & items for inclusion on a future agenda

<u>See Clerk's Report</u> Recommendation: - To receive general updates and resolve to add any matters arising to a future agenda in relation to: -

1. Winterton Hall CIO:

The original conveyance and Deeds have not been located by Nat West Bank. Indications on copies suggest they were originally stored with Westminster Bank in Petworth but since the bank has relocated and changed to Nat West Bank they were either returned at an earlier date or lost.

A document pertaining to indicate the use of the land over the years will be drawn up for signing by the Winterton Hall Trustees to act in the absence of the original documents when registering title.

However, the CIO registration has now taken place although the Title Registration is needed in due course.

- 2. Crouchlands Entrance Area community orchard. WSCC Highways and the National Trust do not own this, and the landowner is to be contacted adjoining this area to establish if they have any knowledge of the ownership.
- 3. Duck Crossing warning signs. Update by Cllr Denyer.
- 4. Cricket Pavilion: Quotes for preserve painting and repairing woodwork.

Two quotes have been requested for this work as during the playground leaf clearance it was noted how bad a state of repair the woodwork beneath the roof line was and that preserving and some repair was required.

S G Carpentry- No response to request.

Description of Works: Rejuvenation of Plaistow Cricket Pavillion in the Playground.

- 1. Remove Algae from 2 walls by Pressure washing.
- 2. Clean ceiling of porch.
- 3. Re-felt Tap box.
- 4. Replace wood supporting Weather Vane plus Clean and brighten up vane.
- 5. Repair 1 of the rotting 4" support Posts to the porch.
- 6. Replace Rusting Hinges to the 2 x front doors w/6 x 4" stainless steel hinges.
- 7. Replace 2x Facia boards to the front Gable end of the roof.
- 8. Sand down all Joinery woodwork and front support posts before Painting the entire building w/Dark brown preservation treatment

Brambles at the back of the Cricket pavilion have been cleared back and will be included in the grass cutting regime to prevent their re-emergence. Council to discuss whether a composting area could be establish here as a project for the future?

- 5. Spring Litter Picking. 5<sup>th</sup> April 2025 This is being advertised on Facebook with a requirement to register with the Clerk. An emergency number to be given out to all taking part being the Clerk's phone number.
- 6. APM & VE 80 Celebrations. Thursday 8<sup>th</sup> May 2025.
  - A speaker to be identified following the National Trust being unable to attend on the 8<sup>th</sup> May.
  - A grant for a Women in War Silhouette and bunting for the event in the total amount of £214.50 has been submitted and approved.
- 7. Coxes Pond maintenance works. The Coxes Pond bank area is encroaching onto the pond. Late last month Cllr Jordan pollarded one of the alder trees and the last week Sussex Land Services cut back brambles and vegetation to open up the pond. The Council to discuss whether they would like Pond Doctors to investigate water quality and then how to proceed?
  - An informal quote was obtained for silt clearance from Simply Pondz and clearing to 1m depth would cost £25,000 if the debris remained on site.
- 8. Coxes Pond Road Barrier. The Council to discuss this topic as to whether a further barrier to be requested of WSCC Highways now the opening is more exposed following the clearance.
- 9. Shillinglee TRO. 10 additional residents have confirmed support for the TRO application making 14 in total. The TRO application can be submitted but the process is a very long one. The Clerk has contacted WSCC Highways to see if they would meet informally in Shillinglee to discuss where the reduction from 60mph would be best started on the lead in to the residential area.
